



The Center for Sacramento History (CSH) allows reproduction of its photographic and archival collections for personal and reference use. The reproductions may also be licensed for publication, public display, and merchandising under certain restrictions. CSH charges fees for *1*) the reproduction work and *2*) subsequent use of those reproductions. Revenue generated from the purchase and use of reproductions from CSH fund the preservation of its collections. Applicants must state the intended use for each reproduction. CSH reserves the right to refuse any reproduction request. Reproductions may not be copied or resold at any time. Responsibility for possible copyright infringement, invasion of privacy, and the rights of publicity from the use of reproductions is assumed by the applicant. Fees, payable by cash or check made out to the *City of Sacramento*, are due at the time services are rendered. All sales are final.

REPRODUCTION FEES

CSH staff will provide reproductions of its collections provided duplication is not restricted by prior agreement with a donor; can be produced without damage or any substantial risk of damage to the originals; and does not violate the “Fair Use” provision of Title 17 of the United States copyright law. The copyright law governs the making of photocopies or other reproductions of copyrighted material. Under certain conditions specified in the law, libraries and archives are authorized to furnish a photocopy or reproduction. One of these specified conditions is that the photocopy or reproduction is not to be “used for any purpose other than private study, scholarship, or research.” If a user makes a request for, or later uses, a photocopy or reproduction for purposes in excess of “fair use,” that user may be liable for copyright infringement. CSH reserves the right to refuse to accept a reproduction request if, in its judgment, fulfillment of the order would involve violation of copyright law. Each request for reproduction will be reviewed by staff.

Orders require a **two week turn-around time** (not including mailing time). All in-house copying will be done by CSH staff or trained volunteers only. Scanners and digital cameras are allowed in the reading room upon staff approval only; reproduction fees apply. No more than twenty (20) percent of a collection/printed item/publication/exhibit may be photocopied or reproduced. Any copy negatives created in the production of an order remain the property of CSH. Unless otherwise requested, orders are scanned at the following specifications: 300 ppi, 8” by 10”, TIFF, 8-bit grayscale/24-bit color, full frame, and not retouched.

PHOTOGRAPHING/FILMING of Photographs & Archives

Images/artifacts shot for editorial, non-editorial (merchandising), and advertising is done at CSH facilities only. These photographing/filming/videotaping charges are *in addition* to use fees. Research must be completed, images approved and appointments scheduled in advance of the photographing/filming/videotaping session.

USE FEES

CSH retains all rights to the collections requested for reproduction. Permission for publication is granted for one-time, non-exclusive use and only for the expressed purpose described in the *Copyright Understanding Form*. Any additional or future use of the images and/or documents requires written permission of CSH and payment of applicable fees. All reproductions must be credited as follows:

Center for Sacramento History, [Collection Name], [Accession Number]

Credits should appear in close proximity to the image, exhibition area, or in a section devoted to credits. Altering the original image beyond standard cropping requires written permission from CSH. These changes must be indicated in the accompanying caption. Applicant agrees to provide CSH with one copy of the work containing the reproduction.

A *Copyright Understanding Form* must be completed, stating the intended use of the reproduction, and signed by the requestor. CSH reserves the right to refuse any reproduction request. All responsibility for possible copyright infringement, invasion of privacy, and the rights of publicity from the use of reproductions is assumed by the applicant. For uses not listed below, please contact CSH.

EDITORIAL USE: editorial use within books, periodicals, and other published works (company reports, brochures, etc.). For use on the cover of a magazine or book, *the rate is 2 times the amount listed below*. Subsequent printing and additional uses are normally charged at one-half the original fee, but should be verified and permission granted beforehand. *For a thesis, dissertation, or an unpublished report, non-editorial use fees apply.*

*Non-profit refers to any governmental agency or organization able to demonstrate 501(c)(3) not-for-profit status.

If the footage has not been digitized, we charge \$0.30 per foot to digitize and create a screener.
